Eve contact

#### 6. Accidental Release Measures

Personal precautions

Avoid release to the environment. Contact local authorities in case of spillage to drain/aquatic environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water. Avoid discharge into drains, water courses or onto the ground.

Methods for containment

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Collect spillage. Prevent entry into waterways, sewer, basements or confined areas.

Methods for cleaning up

Ventilate the contaminated area. Extinguish all flames in the vicinity. Wear appropriate protective equipment and clothing during clean-up. Should not be released into the environment. Prevent product from entering drains.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Do not allow material to contaminate ground water system. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Small Spills: Wipe up with absorbent material (e.g., cloth, fleece). Clean surface thoroughly to remove residual contamination.
